We welcome new collaborations in the coming years to further reach those in need and ensure everyone has the right to a safe, secure, suitable place to call home through improving rights enforcement and access social justice. We will continue to build on the excellent collaboration we have with our main funder, South and East Ayrshire Councils who benefit greatly from the work we do in our core objectives of preventing homelessness and negating the need for temporary accommodation. #### BACKGROUND

Ayr Housing Aid Centre SCIO is a local charity operating in South and East Ayrshire, established in 1986 following a Shelter Conference on homelessness. Our primary aims and objectives are to provide free, accredited, independent information, advice, advocacy, representation and engagement services to these who are homeless, threatened with homelessness and/or are in housing need.

We are an OSCR registered Charity and are regulated and inspected by the Care Inspectorate and accredited under the Scottish National Standards for Housing Information and Advice Providers at Type III. Our office is based at 7 York Street, Ayr with Prison Housing Advice staff based within HMP Kilmarnock Link Centre.

#### FINANCE STATEMENT

The Centre's income for this financial year was £513,582.14 (£460,733.73 received from Public Authorities as part of the Contract, and £52,848.41 from fundraising, donations and other income.

Expenditure for the year was £446,211.76. The primary expenditure heading was salaries including pensions, which accounted for £369,447.65.

Due to increases in case numbers Ayr Housing Aid Centre SCIO continue to apply for additional funding and resources to compliment core council funding. We continue to evolve to meet changing needs and aspirations including eviction bans, cost of living restrictions, legislative and regulatory changes and challenges.

#### I'M IN! PROJECT

I'M IN! is a collaboration between Ayr Housing Aid Centre SCIO and SeAscape providing early upstream advice, advocacy and short term support to people threatened with homelessness from the private sector.

#### VASA CASEWORKER

The VASA Mental Health and Wellbeing funding has allowed us to employ a Caseworker to help more vulnerable people by empowering them to enforce their housing rights, alleviate poverty and improve mental health.



#### TRIBUNAL OFFICER



Our Tribunal Officer actively negotiates with Landlords and Agents to reduce the threat of eviction and crisis. Through preventing homelessness and finding alternative solutions demand on temporary accommodation is reduced. Representation is proved at Tribunal to defend and delay ejections in collaboration with South Ayrshire Council Housing Options to secure positive outcomes.

#### 05 PRISON HOUSING ADVICE



Jointly funded by East and South Ayrshire Councils, AHAC has provided this service since 2017. Based in HMP Kilmarnock, Barlinnie and Greenock our advisers provide advice to people in custody from entry to liberation, this includes remand, convicted, short term and long term prisoners from all tenure types. Our key aim is to reduce and prevent homelessness through early intervention and working collaboratively with Prison staff to identify those in housing need.



Notable figures from cases opened this year:

- 81% had mental and/or physical health issues
- 45% reported having an addiction
- 83% previously had a custodial sentence with 60 people coming back into custody within 1 month of release



#### TENURE SUSTAINMENT SERVICE

CRISIS INTERVENTION, HOMELESS PREVENTION SUPPORT SERVICE

Tenure Sustainment includes liaising, mediating and negotiating with landlords. We request the eviction process is suspended pending our intervention. We support Service Users to understand their tenant rights and responsibilities, housing options, housekeeping and budgeting. A full income maximation check is completed to increased unclaimed benefits and applications for grants are made to reduce poverty. Once crisis is averted we encourage continued engagement with appropriate agencies within the community.


Our Tenure Sustainment Service is Care Inspectorate regulated and staff are SSSC registered.

**CASE STUDY 1** 

#### SINGLE MALE WITH RENT ARREARS DUE TO MENTAL HEALTH:

- £18,925.90 benefit entitlement awarded
- £600 Re-payment plan agreed preventing eviction
- £500 Grants awarded
- Emotional and wellbeing support to promote engagement creating new ability to trust support agencies
- Engaging with Mental Health Team to address complex history of trauma
- Bathroom adaptions completed, improving health
- Time spent on case 108 hours

# VULNERABLE FEMALE WITH DISABILITIES, AT RISK OF HOMELESSNESS DUE TO ARREARS FOLLOWING HUSBAND PASSING:

- £2164.32 Rent Arrears
   Cleared, Homelessness
   Prevented, Tenancy Sustained
- £33,009 Recovered from unknown pension
- £37,206 entitlement awarded, income maximised and poverty alleviated
- £2760 Funeral service payment
- £6933 Grants awarded
- Adaptions made to tenancy (stair lift and rails)
- Mental health and quality of living improved
- Time spent on case 104 hours

I am on the way to being debt free. SAC have agreed to not evict me as long as I keep engaging. I just wanted to thank you for all your help. If you didn't step in & help when you did I don't know where I would be. I honestly can't worth their weight in gold.

#### **CASE STUDY 3**

### SINGLE, VULNERABLE, FEMALE PARENT, LANDLORD SEEKING EVICTION:

- Homelessness delayed offered permanent offer via Homeless application but avoided needing temporary accommodation
- Permanent alternative social tenancy secured prior to ejection date
- Payment plan regarding arrears agreed, income maximised and affordability improved
- Mental health and anxiety reduced by us taking control and taking pressure off
- £1,000 Compensation for Landlord's conduct was provided as part of the disposal of his criminal case
- £2750 received in grants
- 2 Tribunal Case Management Discussions attended

The service I received was first class. When it came to the tribunal everything was explained step by step. The team were very supportive throughout as my case wasn't as straight forward as any other. If the support wasn't in place I genuinely think I would've had a nervous breakdown and that would lead to affecting my family situation.

#### CASE STUDY 4

## RISK OF HOMELESSNESS FOR PERSON IN CUSTODY AND SON IN COMMUNITY:

- Early intervention from entry, working with both individuals in custody and young adult son in community
- £1000 Grant successful to reduce rent arrears and prevent eviction proceedings
- Support referrals made for son to have support whilst his father was in custody, this allowed him to continue studying at college
- Homelessness prevented, preventing the need for temporary accommodation, reducing stress and anxiety

# CASE STUDY 5 RISK OF HOMELESSNESS FOR PERSON IN CUSTODY, DUE TO HOUSING BENEFIT ISSUE:

- Complex case due to nature of crime and short period in temporary accommodation prior to custody with intent to return to SST tenancy
- Following legislative checks and research, housing benefit entitlement established although previously refused
- £1159.08 backdated and benefit reinstated
- £404.32 Council Tax exemption
- Homelessness prevented, arrears cleared and stress reduced.

I kept getting arrears letters and termination paperwork sent to my cell by the council. If I hadn't spoke to the advisers and got help I would have just ended the tenancy to stop the stress from the letters. I would have been homeless when I didn't need to be.

#### **CASE STUDY 6**

## SINGLE NON-VERBAL FEMALE WITH COMPLEX HEALTH ISSUES AND RENT ARREARS:

- £16,742.75 PIP reinstated and backdated
- £11,396 UC + LCWRA reinstated and backdated
- £1,431 rent arrears cleared, preventing homelessness
- £1,200 Bereavement Payments awarded after husband passed
- £150 Warm Home Discount awarded
- £288 CT Discount and Refund
- Repairs completed including gas meter, wheelchair accessibility and shed demolition
- Stirling Park debt paid and all other debt owed to companies written off
- Electric wheelchair provided, Care Package in place and Community Alarm fitted improving living quality
- Death Certificate Issued for late husband, and 'Tell Me Once' updated who contacted all relevant agencies advised of passing

**CASE STUDY 7** 

#### VULNERABLE SINGLE PARENT, STRUGGLING WITH DOMESTIC ABUSE DAMAGE TO HOME:

life was a mess, but Jenn made me feel better in the space of a few hours. I had been trying to get repairs fixed for over a year, but she got them sorted right away. My mental health was improved 100% and it is a weight off my shoulders.

- RSL Landlord completed repairs, preventing homelessness and improving safety and living quality
- Poverty alleviated through income maximisation
- Court Orders in place to give protection in future from abuser, empowered to stay at home with child and not forced to flee
- £2000 Grant awarded to the child for the following:

# ELDERLY, DISABLED COUPLE TRIBUNAL EVICTION ACTION DUE TO RENT ARREARS:

- Represented at Case Management and Evidential Hearings: successfully preventing eviction and Landlord's expenses dismissed saving £20,000 legal fees
- Income maximised and affordability improved through entitlement of £18,500
- Arrears reduced £9,000
- Remaining in home suitable for their disabilities ensuring quality of living and reducing stress
